

ORDINANCE NO. 18-05

AN ORDINANCE OF THE CITY OF PURCELL, OKLAHOMA (THE "CITY"), RELATING TO THE AMENDMENT OF ORDINANCE NO. 09-07 OF THE CITY, BY EXTENDING THE EXPIRATION DATE; PROVIDING AN EFFECTIVE DATE AND TERMINATION DATE; PROVIDING FOR SEVERABILITY OF PROVISIONS; AND CONTAINING OTHER PROVISIONS RELATED THERETO.

WHEREAS, Ordinance No. 09-07 of the City of Purcell, Oklahoma (the "City") levies an excise tax of one percent (1%) (in addition to any and all other excise taxes now in force) to be levied upon the gross proceeds or gross receipts derived from all sales taxable under the Oklahoma Sales Tax Code for the purpose of providing revenues to be restricted to capital expenditures for the use and benefit of the City and any public trust having the City as beneficiary thereof including, but not limited to, capital improvements to the Purcell Municipal Hospital, acquisition of equipment and vehicles for the police and fire departments, improvements to the City's utility systems and improvements to roads and streets within the City and/or for the payment of debt service in connection with obligations issued to finance said improvements and related costs; and

WHEREAS, by the terms of Ordinance 09-07, the one percent (1%) excise tax so levied shall expire on September 30, 2025; and

WHEREAS, the City Council of the City desires to extend the term of the one percent (1%) excise tax for an additional approximately fifteen (15) years, subject to the approval by a majority of the qualified electors of the City voting on the same in the manner prescribed by law.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PURCELL, OKLAHOMA, AS FOLLOWS:

Section 1. Citations and Codification. This Ordinance shall be known and may be cited as the City of Purcell Capital Expenditures Sales Tax Ordinance of 2018, which is similar to the existing temporary tax known as City of Purcell Sales Tax Ordinance of 2010, and the same shall be codified and incorporated into the Code of Ordinances of the City.

Section 2. Modification of Stated Termination Date of Existing Tax. Ordinance No. 09-07 of the City currently provides for the levy and collection of a one percent (1%) excise tax (sales tax) which currently has a termination date of September 30, 2025, after which said excise tax shall no longer be collected. Ordinance No. 09-07 is hereby amended by providing that the collection of the excise tax referenced herein shall terminate and said excise tax shall not be collected after September 30, 2040.

Section 3. Effective Date and Termination Date. The provisions of this Ordinance, as it amends Ordinance No. 09-07 of the City, shall become effective on and after August 28, 2018, subject to approval by a majority of the qualified electors of the City voting on the same in the manner prescribed by law. The one percent (1%) excise tax referenced herein shall cease to be collected after September 30, 2040.

Section 4. Severability. The provisions of this Ordinance are severable, and if any part or provision hereof shall be adjudged invalid by any court of competent jurisdiction, such adjudication shall not affect or impair any of the remaining parts or provisions hereof.


